COMMUTER STUDENT RESIDENCE

Commuter Community Standards

We are pleased to welcome you to our residence community as a commuter guest and hope that this experience highlights some of the benefits of living in residence. As a commuter guest you are agreeing to a set of behavioural expectations that exist to support learning, wellness and the overall safety of our communities. Below is a summary of some of these expectations. Our commuter guests must also abide by all Federal, Provincial and Municipal laws as well as all University policies and regulations.

ALCOHOL

Alcohol is permitted in residence provided the following:

- ◇ Alcohol is consumed only by those individuals who are of legal age (19);
- ◇ Alcohol is consumed in a responsible manner and not through activities, situations, or sources that could lead to a safety or security risk (ie. Drinking games, parties, large containers, beer bottles etc...);
- ◇ Alcohol is consumed within your room and is not transported through residence in open or unsealed containers.

QUIET HOURS

Our residence areas abide by Quiet Hours to support the personal and academic needs of our residents. During quiet hours noise (ie. Music, voices) should be kept to a minimum so that it does not impact other guests or residents.

Sunday to Thursday – Quiet Hours are observed from 11pm – 8am

Friday & Saturday – Quiet hours are observed from 1am – 8am

(During exam period quiet hours are extended to 23 hours a day).

FIRE SAFETY

Should the fire alarm sound, you are required to evacuate residence via the closest emergency exit. Failing to evacuate or tampering with any fire safety equipment may result in a charge through the University of Guelph Policy on Non-Academic Conduct or Campus Community Police. VISITORS

Given the short stay of our commuter guests, visitors are not permitted. For additional information or inquiries please speak with the Residence Desk.

BUILDING SAFETY

We take great pride in our quality standards and look to our residents and guests to maintain and uphold these standards for our buildings, facilities and property. As a commuter guest you are responsible for any damages or cleanliness issues that may arise in your room during your stay. All members of our community must also abide by our Perimeter Access Program which limits the use of some exterior residence doors.
